**Declaration on the new member of the group  
of Central and Eastern European Data Protection Authorities**

Recognizing principles announced during the 1st Meeting of Central and Eastern European Data Protection Commissioners which took place in Warsaw, on 17 December 2001;

Guided by the provisions contained in the Declaration on future cooperation adopted in Smolenice, on 24 May 2005, and further specified in the Declaration on cooperation adopted in Kazimierz Dolny, on 3 June 2008;

Expressing the need to continue our cooperation and exchange of experiences in the field of personal data and privacy protection.

Acknowledging that in the age of global economy and development of IT technologies, the cooperation between data protection commissioners from various countries plays an essential role in ensuring the efficiency of data protection systems;

Taking into consideration the unique experiences of the members of the group of the Central and Eastern European Data Protection Commissioners in the field of implementation of data protection legislation which may be useful to the countries where data protection legislation has recently been adopted;

In response to the request submitted by the Agency for Personal Data Protection of Armenia for membership in the group of the Central and Eastern European Data Protection Authorities;

**We, the undersigned Commissioners,**

Welcome among us the Armenian Agency for Personal Data Protection;

- Declare the willingness to mutual support and sharing experiences;
- Commit to assist each other in different areas of competence upon request and within our available resources with every effort made to meet requests for cooperation;
- Invite also the Data Protection Authorities created recently in various countries and the countries which have just begun to adopt data protection legislation to cooperate with us;
- Call upon the Council of Europe and the European Commission to promote the

development of data protection legislation and to support the activities of the Agency for Personal Data Protection of Armenia and other countries.
